GUIDELINES

PROCEDURE AND FORMALITIES:

Registration: To be done Online @www.thevikasa.edu.in.

Please refer age criteria for registration (chart attached).

Please mention your ward's name, date of birth and Parents name as on the Birth Certificate.

SCREENING AND COUNSELLING OF STUDENTS:

Students need to attend personal interview and should qualify in the Screening Test which will be conducted on a given date. (During last week of January).

COUNSELLING OF PARENTS AND VERIFICATION OF DOCUMENTS:

Parents should attend a counselling session with the Head of the institution and to submit the Birth Certificate, Passport Size Photo, Aadhar and Community (Certificate of your ward).

Enclose the EMIS number along with the "Promoted" Transfer Certificate.

PROVISIONAL ADMISSION:

Provisional admission will be confirmed only after the completion of admission formalities and fulfilling the admission criteria.

PAYMENT OF SCHOOL FEE:

There is no ADMISSION FEE OR DONATION for admission at The Vikasa schools. However you will be expected to pay the first semester fee to confirm the Provisional Admission of your ward in the school. Kindly refer the school website for the detailed fee structure for all classes. Payment should be made through online only. No cash transaction is permitted at School.
